- WHEREAS:** The Fire Commissioners of Lewis county Fire Protection District Number 15, (Winlock) are the authorized governing body for the Fire District; and,
- WHEREAS:** The District provides fire suppression, rescue and emergency medical services for the protection of life, health, property and welfare of the residents; and,
- WHEREAS:** The Fire Commissioners have the statutory authority to ask the voters of the District to authorize the collection of property tax monies to operate and maintain effective fire & EMS services within the District; and,
- WHEREAS:** The Board of Fire Commissioners has determined that the District will suffer an inability to continue to operate and maintain the delivery of fire & EMS services through 2018 without an additional funding mechanism.

THEREFORE, BE IT RESOLVED THAT: the Board of Fire Commissioners of Lewis County Fire Protection District Number 15, request that the following issue be placed before the voters on November 2017 election ballot.


Lewis County Fire Protection District No. 15 - Winlock
Proposition Authorizing a four-year (2018-2021) Maintenance & Operating (M&O) levy

Should the Lewis County Fire Protection District No. 15 be authorized to impose an excess property tax levy to collect \$215,000 beginning in 2018 and each of the following three years (2019-2021), at an estimated rate of \$0.50 per \$1,000 of assessed property value, to fund the continued maintenance and operation of fire and emergency medical services?


