#### RESOLUTION NO. 2021-03

A RESOLUTION of the Board of Fire Commissioners of Lewis County Fire Protection District No. 1 (Onalaska Fire Department), Lewis County, Washington, relating to the District's regular property tax levy; providing for the submission to the voters of the District at the primary election to be held on August 3, 2021, of a proposition authorizing the District to levy regular property taxes in an amount in excess of the limitations provided in chapter 84.55 RCW; designating the Fire Chief to receive notice of ballot title from the Auditor; and providing for related matters.

#### LEVY LID LIFT FOR SUPPORT OF FIRE SERVICES

#### RESOLUTION NO. 2021-03

A RESOLUTION of the Board of Fire Commissioners of Lewis County Fire Protection District No. 1 (Onalaska Fire Department), Lewis County, Washington, relating to the District's regular property tax levy; providing for the submission to the voters of the District at the primary election to be held on August 3, 2021, of a proposition authorizing the District to levy regular property taxes in an amount in excess of the limitations provided in chapter 84.55 RCW; designating the Fire Chief to receive notice of ballot title from the Auditor; and providing for related matters.

BE IT RESOLVED BY THE BOARD OF FIRE COMMISSIONERS OF LEWIS COUNTY FIRE PROTECTION DISTRICT NO. 1 (ONALASKA FIRE DEPARTMENT), LEWIS COUNTY, WASHINGTON, as follows:

- 1.. <u>Findings and Determinations</u>. The Board of Fire Commissioners (the "Board") of Lewis County Fire Protection District No. 1 (Onalaska Fire Department), Lewis County, Washington (the "District"), takes note of the following facts and makes the following findings and determinations:
  - (a) RCW 52.16.130, RCW 52.16.140 and RCW 52.16.160 limit the District's aggregate regular property tax levy to a maximum dollar rate of \$1.50 per \$1,000 of assessed value of taxable property within the District. Chapter 84.55 RCW further limits the amount of the regular property tax levy to 101% (or 100% plus inflation, if inflation is less than 1%) of the prior highest lawful levy amount (the "levy lid"). Due to the levy lid and increasing property values within the District, the District's current regular property tax levy is limited to a dollar rate of approximately \$0.60 per \$1,000 of assessed value.
  - (b) Under RCW 84.55.050(1), the District may submit to its voters at a general or special election, for their approval or rejection, a proposition authorizing the District to increase its regular property tax levy in an amount exceeding the levy lid in a single year (a "levy lid lift"). Under RCW 84.55.050(3) and (4), the proposition may provide that the District will use the regular property tax levy amount so approved for purposes of computing the levy lid for subsequent levies. Under RCW 84.55.050(4), the proposition may set the regular property tax levy at a rate less than the maximum rate allowed for the District. Under RCW 84.55.050(4) the proposition may provide that the exemption for low-income senior citizens, disabled veterans and other people with disabilities

authorized by RCW 84.36.381 will apply to the levy of any additional regular property taxes authorized by voters.

- (c) The essential and necessary protection of public health, safety, life and property, the continued operation and maintenance of fire services, equipment and facilities of the District and the increased demands and costs of providing fire protection and emergency medical services to the greater Onalaska community require the expenditure of revenues in excess of the levy lid.
- (d) It is therefore in the best interests of the District and its residents to seek voter approval of a levy lid lift proposition authorizing an increase to the District's regular property tax levy for collection in 2022 by a rate of approximately \$0.75 per \$1,000 of assessed value to the maximum aggregate rate of \$1.35 per \$1,000 of assessed value and providing for the exemption authorized by RCW 84.36.381 to apply to such regular property tax levy increase.
- 2.. <u>Description of the Ballot Proposition</u>. The Board seeks voter approval under RCW 84.55.050(1) of a levy lid lift proposition, as follows:
  - (a) <u>Maximum Aggregate Levy Rate Authorized</u>. The proposition authorizes the District to restore its maximum aggregate regular property tax levy to the amount resulting from a rate of \$1.35 per \$1,000 of assessed value for levy in 2021 and collection in 2022, which represents a rate that is less than the maximum rate allowed for the District.
  - (b) <u>Computing the Limitations for Subsequent Levies</u>. The District will use the dollar amount of the maximum aggregate property tax levy resulting from a rate of \$1.35 per \$1,000 of assessed value for levy in 2021 and collection in 2022 for the purpose of computing the limitations for subsequent levies under chapter 84.55 RCW.
  - (c) <u>Exemption</u>. The exemption authorized by RCW 84.36.381 applies to the additional regular property taxes authorized by this proposition.
- 3.. <u>Calling of Election</u>. The Auditor of Lewis County, Washington, as *ex officio* Supervisor of Elections (the "Auditor"), is requested to call and conduct a primary election, in the manner provided by law, to be held in the District on August 3, 2021 (the "Primary Election"), for the purpose of submitting to the District's voters, for their approval or rejection, the proposition authorizing the District to increase its regular property tax levy in 2021 for collection in 2022 by an amount greater than otherwise permitted under chapter 84.55 RCW and to use the dollar amount of such levy for the purpose of computing the limitations for the District's subsequent levies under chapter 84.55 RCW.

4.. <u>Form of Ballot Title</u>. Pursuant to RCW 29A.36.071, the Lewis County Prosecuting Attorney is requested to prepare the concise description of the aforesaid proposition for the ballot title in substantially the following form:

#### PROPOSITION 1

#### LEVY LID LIFT FOR SUPPORT OF FIRE SERVICES

The Board of Fire Commissioners of Lewis County Fire Protection District No. 1 (Onalaska Fire Department) adopted Resolution No. 2021-03, concerning an increase in fire services funding.

This proposition would provide funds for the continued operation and maintenance of fire services, equipment and facilities. It authorizes a maximum regular property tax rate for collection in 2022 of \$1.35 per \$1,000 of assessed valuation. The 2022 levy amount will be used for the purpose of computing the limitations for subsequent levies under chapter 84.55 RCW. Qualifying low-income seniors, disabled veterans and other people with disabilities will be exempt from the levy increase under RCW 84.36.381.

Duties. The Fire Chief of the District (the "Fire Chief") or his or her designee is authorized and directed to: (a) present a certified copy of this resolution to the Auditor no later than May 14, 2021; and (b) perform such other duties as are necessary or required by law to submit to the District's voters at the Special Election, for their approval or rejection, the proposition authorizing the District to increase its regular property tax levy in 2021 for collection in 2022 by an amount greater than otherwise permitted under chapter 84.55 RCW and to use the dollar amount of such levy for the purpose of computing the limitations for the District's subsequent levies under chapter 84.55 RCW. If after submitting this resolution to the Auditor, the Fire Chief, in consultation with the Chair of the Board and the Auditor, determines it is not in the District's best interests to submit the proposition authorized in this resolution to the District's voters at the Special Election due to circumstances regarding the coronavirus disease 2019 (COVID-19), the Fire Chief is authorized to request and direct the Auditor to remove the proposition from the Special Election ballot without further Board action.

- 6.. <u>Notices Relating to Ballot Title</u>. For purposes of receiving notice of the exact language of the ballot title required by RCW 29A.36.080, the Board hereby designates the Fire Chief (Brad Flexhaug), telephone: 360.520.3820; email: <a href="mailto:chieflefd1@gmail.com">chieflefd1@gmail.com</a>; as the individual to whom the Auditor shall provide such notice. The Fire Chief is authorized to approve changes to the ballot title, if any, determined necessary by the Auditor or the Lewis County Prosecuting Attorney.
- 7.. <u>General Authorization and Ratification of Prior Acts</u>. The Fire Chief, the Secretary, the Chair of the Board, other appropriate officers of the District are severally authorized and directed to take any action and to execute any document as in their judgment may be necessary or desirable to effectuate the provisions of this resolution. All actions taken prior to the effective date of this resolution in furtherance of and not inconsistent with the provisions of this resolution are ratified and confirmed in all respects.
- 8.. <u>Severability</u>. If a court of competent jurisdiction, all appeals having been exhausted or all appeal periods having run, holds any provision of this resolution invalid or unenforceable, then the offending provision is null and void, is separate and severable from the remaining provisions of this resolution and in no way affects the validity of the other provisions of this resolution or of the levy or collection of the regular property taxes as so authorized herein.
  - 9.. <u>Effective Date</u>. This resolution takes effect from and after its adoption.

#### PROPOSITION 1 LEVY LID LIFT FOR SUPPORT OF FIRE SERVICES

Lewis County Fire Protection District No. 1 (Onalaska Fire Department) provides fire protection, rescue and emergency medical services to the greater Onalaska community.

The maximum regular levy rate for Washington fire districts is \$1.50 (per \$1,000 of assessed value). Due to the statutory 1% limitation on property tax increases, the Onalaska Fire Department's current levy rate in 2021 is under \$0.60.

The Board of Fire Commissioners has determined that the continued operation and maintenance of fire services, equipment and facilities of the District and the increased demands and costs of providing fire protection and emergency medical services to the greater Onalaska community require the expenditure of revenues in excess of the current limit.

Proposition 1 will restore the District's regular property tax levy to \$1.35 in 2022, which is \$0.15 below the maximum rate allowed by law. The 2022 levy amount will be used to calculate subsequent levy limits. The estimated increase would equal approximately \$12.50 per month for a \$200,000 home. Proposition 1 includes the property tax exemption for qualifying low-income seniors, disabled veterans and other people with disabilities under RCW 84.36.381.
