## 2021 SPECIAL THREE DAY FILING PERIOD

The positions in the following jurisdictions subject to the General Election on November 2, 2021 received no declared candidates, in-person, online or by mail, during the 2021 filing period.

As a consequence, a special **three-day filing period** for the below-listed voids in candidacy will be held Tuesday, May 25<sup>th</sup> through Thursday, May 27<sup>th</sup>. Candidates may file in-person at the Lewis County Auditor's Office during normal business hours 8:00 a.m. – 4:30 p.m. Online filings will be accepted from 9:00 a.m. Tuesday and continue until 4:00 p.m. Thursday at <u>elections.lewiscountywa.gov</u>.

Candidates that file for any of the below offices during the special 3-day filing period will go straight to the General Election ballot, regardless of the number of candidates that file.

Any office with a void in candidacy remaining after the special three-day filing period will be deemed lapsed, the office stricken from the General Election ballot, no write-in votes will be counted, and the incumbent (if any) will remain in office until the next election for said office. (RCW 29A.24.201)
