#### CENTRALIA SCHOOL DISTRICT NO. 401

#### REPLACEMENT EDUCATIONAL PROGRAMS AND OPERATIONS LEVY

The Board of Directors of the Centralia School District adopted Resolution No. 2022-19 concerning this proposition to maintain educational funding. This proposition authorizes the District to levy the following excess taxes, to replace an expiring levy, on all taxable property within the District, to support the District's educational programs and operations not funded by the state:

**STADIUM COMPLETION PROJECT CAPITAL PROJECTS LEVY**

The Board of Directors of Toledo School District adopted Resolution No. 2022-23-02 concerning capital improvement levies. This proposition authorizes the undertaking of the Stadium Completion Project, including rubberized track and field facility, concessions, restrooms and under-grandstand storage and authorizes the following excess levies for such purposes on all taxable property within the District:

**PROPOSITION NO. 1**

**NAPAVINE SCHOOL DISTRICT NO. 14**

**BONDS TO IMPROVE SAFETY AND EXPAND AND RENOVATE JUNIOR/SENIOR HIGH FACILITIES**

The Board of Directors of Napavine School District No. 14 adopted Resolution No. 22-23-02, concerning bonds to improve safety, relieve overcrowding, and enhance learning environment. This proposition would authorize the District to: expand and renovate Junior/Senior High Facilities (including making health, safety, accessibility and infrastructure improvements; constructing secured controlled entry and kitchen; expanding cafeteria/commons; constructing a new, permanent classroom building for middle school students; constructing a new middle school auxiliary gymnasium); issue no more than \$17,000,000 of general obligation bonds maturing within 25 years; and levy annual excess property taxes to repay the bonds, all as provided in Resolution No. 22-23-02.
