#### Proposition No. 1 Toledo School District

##### Replacement Educational Programs and Operations Levy

The Board of Directors of Toledo School District adopted Resolution No. 2023-24-07 concerning a replacement levy for education. This proposition would authorize the District to levy the following excess taxes, to replace an expiring levy to support the District's educational programs and operations which are not funded or not fully funded by the State:

Collection	Estimated Levy Rates/\$1000	Levy

2025	\$1.34	\$1,640,000
2026	\$1.34	\$1,780,000
2027	\$1.34	\$1,930,000

#### Proposition No. 1 Lewis County Fire Protection District No. 17

##### Authorizing Regular Property Tax Levy

The Board of Fire Commissioners of Lewis County Fire Protection District No. 17 (the "District"), adopted Resolution No. 24-001 concerning the District's regular property tax levy. This measure would authorize a regular property tax levy of One Dollar (\$1.00) per One Thousand Dollars (\$1,000.00) of assessed valuation in 2024 (for collection in 2025), and the resulting levy dollar amount would thereafter be used for the purpose of computing the limitations for subsequent levies under RCW 84.55.050.

### **Proposition No. 2 Lewis County Fire Protection District No. 17**

#### **Authorizing Regular Property Tax Levy**

The Board of Fire Commissioners of Lewis County Fire Protection District No. 17, adopted Resolution No. 24-002 authorizing a regular property tax levy for Emergency Medical Services of Fifty Cents (\$0.50) per One Thousand Dollars (\$1,000.00). This proposition would authorize the District to restore its regular property tax levy of Fifty Cents (\$0.50) per One Thousand Dollars (\$1,000.00) of assessed valuation for 2024 and thereafter pursuant to RCW 84.55.050. The dollar amount of this levy would be used for the purpose of computing the limitations for subsequent levies under RCW 84.55.050.
