EXPLANATORY STATEMENT - PROPOSITION NO. 1

Passage of Proposition No. 1 would allow Castle Rock School District No. 401 to replace an existing educational programs and operation levy that will expire at the end of calendar year 2025. The proposed three-year replacement educational programs and operation tax levy would authorize collection of taxes to provide up to \$3,397,250 in property taxes within the District for collection in 2026, the levy of \$3,635,000 for collection in 2027, and the levy of \$3,889,500 for collection in 2028, to support the District's educational programs and operations, that are not fully funded by the State of Washington, and properly meet the educational needs of the students attending District schools. In accordance with Resolution No. 2024-141, these taxes would be collected over three years and deposited in the District's General Fund to pay part of the educational program and operations support of the District. If authorized by the voters, and based on projected assessed valuation information, estimated levy rates per \$1,000 of assessed value would be \$1.72 (2026 collection), \$1.75 (2027 collection), and \$1.79 (2028 collection). The exact levy rate shall be adjusted based upon the actual assessed value of the property within the District at the time of the levy.

Exemptions from taxes may be available to certain homeowners. To determine if you qualify, contact your county assessor.

RESOLUTION NO. 2024-141

A RESOLUTION of the Board of Directors of Castle Rock School District No. 401, Cowlitz and Lewis Counties, Washington, providing for the submission to the qualified electors of the District at a special election to be held therein on February 11, 2025, of the proposition of whether excess taxes should be levied of \$3,397,250 in 2025 for collection in 2026, \$3,635,000 in 2026 for collection in 2027, and \$3,889,500 in 2027 for collection in 2028, said excess taxes to pay part of the educational program and operations support of the District.

WHEREAS, Castle Rock School District No. 401, Cowlitz and Lewis Counties, Washington (the "District"), for the past two years has had in effect an educational programs and operations levy in order to enable the District to pay for its educational programs and services, including teaching, school supplies, technology, athletics, and buildings; and

WHEREAS, the current educational programs and operations levies expire this year; and WHEREAS, the money in and to be paid into the General Fund of the District during the 2026 through 2028 calendar years will be insufficient to enable the District to pay for necessary educational programs and operations and to properly meet the educational needs of the students attending District schools; and

WHEREAS, the existing authority for the imposition of local tax levies and use of local revenues (including the proceeds of tax levies) has been modified most recently by Chapter 410, Laws of 2019 (66th Legislature, 2019 Regular Session) and may be modified in the future by the State Legislature; and

WHEREAS, in order to properly provide for such educational programs and operations needs, the Board of Directors of the District deems it necessary to levy the following taxes upon all of the taxable property within the District in excess of the maximum annual tax levy permitted by law to be levied within the District without a vote of the electors:

- A. A tax of approximately \$1.72 per thousand dollars of assessed valuation to provide \$3,397,250, said levy to be made in 2025 for collection in 2026;
- B. A tax of approximately \$1.75 per thousand dollars of assessed valuation to provide \$3,635,000, said levy to be made in 2026 for collection in 2027;
- C. A tax of approximately \$1.79 per thousand dollars of assessed valuation to provide \$3,889,500, said levy to be made in 2027 for collection in 2028; and

WHEREAS, prior to the time the ballot proposition authorized in this resolution is submitted to the voters, the District will have received approval of its educational programs and operations/enrichment tax levy expenditure plan from the Office of the Superintendent of Public Instruction as required under RCW 84.52.053(4); and

WHEREAS, the Constitution and laws of the State of Washington require that the question of whether or not such excess taxes may be levied must be submitted to the qualified electors of the District for their ratification or rejection;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF CASTLE ROCK SCHOOL DISTRICT NO. 401, COWLITZ AND LEWIS COUNTIES, WASHINGTON, as follows:

Section 1. The following taxes for the District's General Fund should be levied upon all of the taxable property within the District in excess of the maximum annual tax levy permitted by law to be levied within the District without a vote of the electors:

- A. \$3,397,250, said levy to be made in 2025 for collection in 2026;
- B. \$3,635,000, said levy to be made in 2026 for collection in 2027; and
- C. \$3,889,500, said levy to be made in 2027 for collection in 2028.

The estimated levy rate depends upon the final dollar amount of assessed value of the property within the District. At this time, based upon information provided by the Cowlitz County and Lewis County Assessor's office, the estimated levy rate for the 2025 levy is \$1.72 per thousand

dollars of assessed valuation, the estimated levy rate for the 2026 levy is \$1.75 per thousand dollars of assessed valuation, and the estimated levy rate for the 2027 levy is \$1.79 per thousand dollars of assessed valuation. The exact levy rate shall be adjusted based upon the actual assessed value of the property within the District at the time of the levy. Upon approval by the voters of the proposition substantially in the form set forth below, the District may use the proceeds of said levies during the 2025-2026, 2026-2027, 2027-2028, and 2028-2029 school years by incurring an indebtedness by the issuance of short term obligations against the General Fund of the District, as authorized by Chapter 39.50 RCW, and may expend the proceeds of said levies to pay such part of the general expenses of educational programs and operations of the District during such school years as may be authorized or allowed by law for the use of excess levy funds.

Section 2. It is hereby found and declared that the best interests of the District require submission to the qualified electors of the District of the proposition of whether or not the District shall levy such excess tax for their ratification or rejection at a special election to be held therein on February 11, 2025.

The Cowlitz County Auditor, as *ex officio* supervisor of elections is hereby requested to call and conduct said special election to be held within the District on said date and to submit to the qualified electors of the District the proposition set forth below. The Secretary of the Board is hereby authorized and directed to certify the proposition to said officials in the following form:

authorized to approve changes to the ballot title, if any, deemed necessary by the Cowlitz County Auditor or the Cowlitz County Prosecuting Attorney.

Section 4. Pursuant to RCW 29A.32, the Board of Directors hereby confirms the District's participation in the local voters' pamphlet for the February 11, 2025 election, which shall be prepared and published by Cowlitz County Elections and Lewis County Elections, including, but not limited to, an explanatory statement reviewed and approved by the District's attorney, and, if available, a Statement For and a Statement Against. The District understands and agrees that it will be required to pay its proportionate share of the expenses of the voters' pamphlet.
