A RESOLUTION of the Board of Directors of Mossyrock School District No. 206, Lewis County, Washington, providing for the submission to the qualified electors of the District at a special election to be held therein on April 22, 2025, of the proposition of whether excess taxes should be levied of \$1,475,686 in 2025 for collection in 2026, \$1,647,682 in 2026 for collection in 2027, and \$1,741,495 in 2027 for collection in 2028, said excess taxes to pay part of the cost of educational programs and operations support of the District.

RESOLUTION NO. 24.25.08

A RESOLUTION of the Board of Directors of Mossyrock School District No. 206, Lewis County, Washington, providing for the submission to the qualified electors of the District at a special election to be held therein on April 22, 2025, of the proposition of whether excess taxes should be levied of \$1,475,686 in 2025 for collection in 2026, \$1,647,682 in 2026 for collection in 2027, and \$1,741,495 in 2027 for collection in 2028, said excess taxes to pay part of the cost of educational programs and operations support of the District.

WHEREAS, Mossyrock School District No. 206, Lewis County, Washington, (the "District"), for the past three years has had in effect an educational programs and operations levy in order to enable the District to pay for its educational programs and services, including teaching, school supplies, athletics, buildings, transportation; and

WHEREAS, the current school programs and operations levies expire in 2025; and

WHEREAS, the money in and to be paid into the General Fund of the District during the 2025-2026, 2026-2027, 2027-2028, and 2028-2029 school years will be insufficient to enable the District to pay for necessary educational programs and operations and to properly meet the expenses of educational programs and operation that are not fully funded by the State of Washington, including, but not limited to, expenses of educational programs and operation that are not fully funded by the State of Washington, including, but not limited to, expenses of educational programs and operation that are not fully funded by the State of Washington, including, but not limited to, teaching, school supplies, athletics, buildings and transportation (field trips, etc.), special education programs, student technology and curriculum materials, maintenance of facilities, and other non-capital expenses necessary in the operation of the District; and

WHEREAS, the existing authority for the imposition of local tax levies and use of local revenues (including the proceeds of tax levies) has been modified most recently by Chapter 410,

Laws of 2019 (66th Legislature, 2019 Regular Session) and may be modified in the future by the State Legislature; and

WHEREAS, in order to properly provide for such educational programs and operations and such educational needs, the Board of Directors of the District deems it necessary to levy the following taxes upon all of the taxable property within the District in excess of the maximum annual tax levy permitted by law to be levied within the District without a vote of the electors:

- A. A levy in the amount of up to \$1,475,686, said levy to be made in 2025 for collection in 2026;
- B. A levy in the amount of up to \$1,647,682, said levy to be made in 2026 for collection in 2027;
- C. A levy in the amount of up to \$1,741,495, said levy to be made in 2027 for collection in 2028; and

WHEREAS, prior to the time the ballot proposition authorized in this resolution is submitted to the voters, the District will have received approval of its educational programs and operations/enrichment tax levy expenditure plan from the Office of the Superintendent of Public Instruction as required under RCW 84.52.053(4); and

WHEREAS, the Constitution and laws of the State of Washington require that the question of whether or not such excess taxes may be levied must be submitted to the qualified electors of the District for their ratification or rejection;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF MOSSYROCK SCHOOL DISTRICT NO. 206, LEWIS COUNTY, WASHINGTON, as follows:

<u>Section 1</u>. The following taxes for the District's General Fund should be levied upon all of the taxable property within the District in excess of the maximum annual tax levy permitted by law to be levied within the District without a vote of the electors:

- A. A levy in the amount of up to \$1,475,686, said levy to be made in 2025 for collection in 2026;
- B. A levy in the amount of up to \$1,647,682, said levy to be made in 2026 for collection in 2027; and
- C. A levy in the amount of up to \$1,741,495, said levy to be made in 2027 for collection in 2028.

The estimated levy rate depends on the limitations of state law. At this time, based on state law, the estimated levy rate for the 2025 levy is \$1.27 per thousand dollars of assessed valuation, the estimated levy rate for the 2026 levy is \$1.27 per thousand dollars of assessed valuation. The estimated levy rate for the 2027 levy is \$1.27 per thousand dollars of assessed valuation. The exact levy rate and amount shall be adjusted based upon the legal levy limits and the actual assessed value of the property within the District at the time of the levy. Upon approval by the voters of the proposition substantially in the form set for the below, the District may use the proceeds of said levies during the 2025-2026, 2026-2027, 2027-2028, and 2028-2029 school years by incurring an indebtedness by the issuance of short term obligations against the General Fund of the District, as authorized by Chapter 39.50 RCW, and may expend the proceeds of said levies to pay such part of the general expenses of educational programs and operations of the District during such school years as may be authorized or allowed by law for the use of local levy funds.

Section 2. It is hereby found and declared that the best interests of the District require the submission to the qualified electors of the District of the proposition of whether or not the District shall levy such excess tax for their ratification or rejection at a special election to be held therein on April 22, 2025.

The Lewis County Auditor, as *ex officio* supervisor of elections in Lewis County, Washington, is hereby requested to call and conduct said special election to be held within the

District on said date and to submit to the qualified electors of the District the proposition substantially in the form hereinafter set forth. The Secretary of the Board of Directors is hereby authorized and directed to certify said proposition to the Lewis County Auditor substantially in the following form:

EXPLANATORY STATEMENT - PROPOSITION NO. 1

Passage of Proposition No. 1 would help Mossyrock School District No. 206 fund educational programs and operations not funded by the State of Washington, including, but not limited to: teaching, school supplies, athletics, buildings and transportation (field trips, etc.), maintenance and operations outside of basic education funding, special education programs not funded through basic education, student technology and curriculum materials.

The proposed three-year levy will replace the District's current levy approved by the voters in 2022 that expires at the end of 2025. If authorized by the voters, and based on projected assessed valuation information, the 2025 levy amount (2026 collection) is \$1,475,686, with estimated levy rate per \$1,000 of assessed value of \$1.27; 2026 levy amount (2027 collection) is \$1,647,682, with estimated levy rate per \$1,000 assessed value of \$1.27; and the 2027 levy amount (2028 collection) is \$1,741,495, with \$1.27 levy rate per \$1,000 of assessed value. The exact levy rate shall be adjusted based upon the actual assessed value of the property within the District at the time of the levy.

Exemptions from taxes may be available to certain homeowners. To determine if you qualify, call the Lewis County Assessor at 360.740.1392.
