

# 2025 SPECIAL THREE-DAY FILING PERIOD

The following positions in jurisdictions subject to the August 5, 2025 Primary received no declared candidates during the regular filing period held in the County Auditor's office from 8 am Monday, May 5<sup>th</sup> through 5:00 pm Friday, May 9<sup>th</sup>.

Therefore, a special **three-day filing period** will commence on Monday, **May 19<sup>th</sup>** at 8:00 am and will end Wednesday, **May 21<sup>st</sup>** at 5:00 pm in the County Auditor's office. Online filing will open 8:00 am Monday until 5:00 pm Wednesday at <https://voter.votewa.gov/candidatefiling/candidatelogin.aspx>

All declarations of candidacy will be accepted at the Auditor's Office in the Historic Courthouse, 351 NW North St, Chehalis, for the below-listed voids in candidacy. Any candidates who file for any of the offices below during the special 3-day filing period will be on the November 4, 2025 General Election ballot, regardless of the number of candidates. There is no withdrawal period when filing in the three-day special filing.

Any office with a void in candidacy remaining after the special three-day filing period will be deemed lapsed and removed from the General Election ballot. No write-in votes will be allowed, and the incumbent (if any) will remain in office until the next election for said office. (RCW 29A.24.201)
